INTRODUCTION AND OBJECTIVES

The idea for change by the people and for the people

The civic space is shrinking across many countries. In Nigeria, the excesses in government's arbitrariness, clampdowns on social media and stereotypes mainly limit the civic space. There is increasing attempt by the National Assembly and law enforcement to gag civil society with restrictions on participation, freedom of expression and assembly, and access to information, these actions are also closing the civic space, limiting the operational effectiveness of Civil Society Organizations (CSOs), stifling civic participation, heightening the security risks for local staff, and affecting the involvement of key players, especially women.

These challenges are further exacerbated by a lack of support, mentorship, and training for citizens and community/youth-led startup organizations to possess the tools to advocate, understand, and react to the situation.

In 2020, TransparencIT launched the Civic Changemakers Fellowship program using interdisciplinary modules and actionable insights from data to train, mentor, and support community champions and startups to strengthen the civic space and enhance the resilience of local and youth-led organizations to solve civic and governance challenges in their communities.

The Civic Changemakers Fellowship seeks to address the shrinking civic space as a precondition for good governance, inclusive growth, effective open government policies, and increased civic participation to achieve the Sustainable Development Goals (SDGs).

The sole mission of the program is to make a difference in the lives of our communities by developing the knowledge, skills, values, and motivation of community champions to learn new skills and drive positive change.

The program focuses on experiential learning and leadership development using cuttingedge technology and digital classrooms for facilitators and learners to streamline learning processes and outcomes in a quicker and more organized way. It partners with local and international organizations to deliver hands-on training and empower the fellows. The program goes beyond teaching and learning to incubating viable solutions that solve myriads of local social justice and governance issues in line with the SDGs.

THE CIVIC CHANGEMAKERS FELLOWSHIP

Empowering the next generation of community champions...

The Civic Changemakers Fellowship (CCF) program was launched in 2020 for residents of Kaduna State and subsequently expanded to other States in Nigeria. In 2021, the program received support from The Governance Lab of Northeastern University, Boston, USA, which provided learning resources to the Changemakers.

The program focuses on individuals who work in the social sector and are dedicated to solving civic and social justice issues. The Fellowship provides participants with practical skills and values for social change, productive engagement, leadership, inclusion and diversity. The Changemakers also engage in virtual learning experiences and discussions with experienced mentors in the development space.

Upon completing the program, Changemakers will have a deeper understanding of how to solve public problems and advance social justice in their communities. They will be empowered and inspired to take further action, driven by new ideas and skills, and become part of a growing network of active community champions.

To empower, inspire & connect community champions to drive positive change.

THE FELLOWSHIP STRUCTURE

A fellowship program enabled by technology

The Civic Changemakers Fellowship is a 12-week online program that utilizes the power of Google products, including Google Drive, Meet, Classroom, Chat, Forms, Looker Studio, Docs, Sheets, and Slides, as its primary tools to provide training sessions, collaborations among fellows, speakers and mentors. These tech tools provide access to global leaders in the civic space and allow fellows to learn and develop innovative solutions to civic problems in their communities.

The program is made up of three courses, each containing 3-4 modules that are approximately two hours long and taught on a weekly basis. Upon completion, the fellows undertake selected online courses from The Governance Lab and submit civic action plans from which innovative ideas are selected and incubated after the close-out session.

In the three cohorts conducted so far, fellows received training on GovTech, Civic Tech, and Data Analysis from experts who shared their experiences and insights on how technology can be leveraged to promote civic engagement and its impact on communities. All training sessions were recorded and saved on Google Cloud for future reference or iteration.

As the fellowship program continues to expand and grow, TransparencIT seeks support and partnerships from organizations and individuals who share its vision of using technology to enable civic engagement and build a strong community of civic changemakers to drive positive change at the grassroots level.

THE PROGRAM ACTIVITIES

Catalyzing community change, one action at a time

Speaker Series

The Speaker Series is an essential component of the Civic Changemakers Fellowship program. It is a platform where experienced professionals, leaders, and changemakers from various fields share their knowledge, experience, and insights with the fellows. The series provides the changemakers with a diverse perspective on civic innovation and governance and equips them with the skills and knowledge necessary to address the challenges in their communities.

The Speaker Series features experts like government officials, social entrepreneurs, academics, activists, and civil society leaders. So far, we have conducted thirty-one (31) sessions. All sessions were virtual and interactive and provided a forum for the fellows to ask questions, share ideas, and engage with the speakers. The sessions covered a wide range of topics, including leadership, public policy, civic tech and engagement, project management, campaign design, community mobilization, diversity and inclusion, advocacy, grant management, etcetera.

Online Courses

The online course activity is designed to provide the fellows with third-party resources and an in-depth understanding of the social change-making concept to support them in solving social justice issues in their communities.

The fellows take online courses on Solving Public Problems and Open Justice from a dedicated web application developed by the Governance Lab of the Burnes Centre for Social Change, Northeastern University, Boston, USA. The Governance Lab supports the programme with learning resources at no cost to increase the program's learning outcomes.

The two online courses provided the fellows with a wealth of learning resources, including videos, reading materials, quizzes, and interactive exercises. The courses are flexible and self-paced, allowing the fellows to learn at their own pace and convenience during the fellowship program.

Civic Action Plan

As a requirement for completion of the program, fellows develop and submit a Civic Action Plan (CAP) aimed at benefitting a defined group or community that is considered disenfranchised or has a civic and governance challenge. The CAP is a comprehensive strategy that outlines the problem, stakeholders, resources, timeline, budget, and expected outcomes of the proposed intervention. The CAP allows the fellows to put into practice all that was learned during the speaker series and the online course. The plan must align with the Sustainable Development Goals (SDGs) and demonstrate a clear pathway towards achieving the desired social impact.

The Civic Action Plan also fosters networking and collaboration among fellows and relevant stakeholders. The activity creates a platform for fellows to exchange ideas, resources, and knowledge and form partnerships with other community champions and organizations working on similar challenges. Through the Civic Action Plan, fellows leverage the power of collective action and maximize the impact of their interventions.

So far, the program has supported the implementation of twenty-five (25) Civic Action Plans in various States nationwide.

Close-out and Projects Showcase Session

The close-out and project showcase session, also known as Civic Changemakers Day (CCD), is the last day and final activity for each program cohort. The session provides a platform for the fellows to showcase the results of their projects and present their civic action plans to stakeholders. In this activity, the fellows demonstrate the impact of their projects, share their experiences, challenges, and lessons learned during the fellowship, and network with potential partners and supporters.

Upon graduation from the program, fellows are issued certificates to mark the end of the program and admitted into the Civic Changemakers Fellowship Alumni Network (CCFAN) to connect with past fellows and receive regular support on their projects and leadership journeys.



THE IMPACT OF THE FELLOWSHIP

Transforming communities through changemakers

In the first three cohorts of the program, the Civic Changemakers Fellowship received an impressive number of 418 applications, demonstrating the strong interest and commitment of individuals to address civic and governance challenges in Nigeria. From this pool of applicants, 25 exceptional fellows were carefully selected, representing a diverse group of changemakers ready to make a difference in their communities.

The fellowship program has supported a total of 18 organizations that align with the Sustainable Development Goals, focusing on areas such as good health and well-being, quality education, gender equality, decent work and economic growth, reduced inequalities, climate action, peace, justice, and strong institutions. The support to these organizations amplifies the program's impact in addressing critical societal issues through a multidimensional approach.

The fellows have successfully executed 21 projects, demonstrating their innovative ideas and unwavering dedication to driving positive change. These projects directly impacted over 11,000 beneficiaries, improving their lives and addressing critical social justice issues in communities across 14 states, which are Kaduna, Lagos, Kano, Ondo, Nassarawa, Kogi, Ogun, Benue, Oyo, Bauchi, Borno, Kwara, Rivers, and the Federal Capital Territory (Abuja).

The Shin Kun Sheda? project, which was incubated during the first cohort of the fellowship, is an inspiring example of the program's impact. The project has made a significant impact, with over 5 million people reached through its multi-media platforms and local radio programs and 30 community dialogues conducted to facilitate accountability and transparency in governance. Through its innovative approach of disseminating credible financial information like budget, debt analysis, procurement information, sector performance, federal allocation, and internally generated revenue in a simplified Hausa language, the project empowers grassroots communities to demand accountability, transparency, and inclusion in public institutions. The addition of animations and infographics has further enhanced the accessibility of financial information to the grassroots. The project is a shining example of the transformative power of training and mentoring community champions to address social justice and equity issues. The impact of the fellowship extends beyond the immediate beneficiaries, as evidenced by the remarkable social media analytics. The program generated 1.27 million impressions, indicating significant online visibility and engagement. With 29,000 social media interactions and an impressive reach of over 884,000, the fellowship's message and activities resonated with a wide audience, sparking discussions and raising awareness about civic participation, good governance, and social justice.

These metrics collectively demonstrate the far-reaching impact of the Civic Changemakers Fellowship and the extent to which it has empowered a group of dedicated individuals, supported a network of organizations, and executed impactful projects that have positively influenced the lives of thousands of beneficiaries. Through its reach, engagement, and geographic spread, the fellowship has created a ripple effect of inspiring others and fostering a culture of active citizenship and social change in Nigeria.

PROGRAM PARTNERSHIPS

Partnerships that work for the good of the people

TransparencIT collaborates and partners with local and international organizations to implement the Civic Changemakers Fellowship program. The partnerships provide experienced facilitators and trainers from the academia, government, and civil society organizations like The Governance Lab, Accountability Lab, BudgIT, Kaduna State Government, and the University of Georgia to deliver hands-on training, mentorship, and support to the community champions in the fellowship. These facilitators also offer technical assistance and guidance to help the fellows incubate viable local solutions and expand the civic space.

The program is affiliated with the Burnes Center for Social Change, Northeastern University, Boston, USA. The Center supports the program with valuable learning resources. The partnership with The Governance Lab also allows fellows to register and undertake its online courses on Solving Public Problems and Open Justice, at no cost.

These partnerships and collaborations established with different stakeholders have been instrumental in the success of the Civic Changemakers Fellowship program.

CHALLENGES

- The program operates in a challenging environment where the civic space is shrinking, and civil society faces increasing restrictions. These limitations hinder the implementation of projects and initiatives of the community champions, posing challenges in navigating bureaucratic hurdles and fostering collaboration with governmental institutions.
- Sustaining the impact of the fellows' projects beyond the fellowship duration is also a challenge. Community champions face difficulties securing long-term funding, scaling their initiatives, and ensuring sustainability due to the shrinking space, even though the fellowship takes them through rigorous training on financing, limited opportunities for startups are still a challenge.
- The Civic Changemakers Fellowship program also faces limited funding support, which hampers its ability to increase its reach and impact. The limited funding support poses constraints on various aspects of the program, including training resources, access to specialized expertise, tailored mentorship, and project implementation support, such as providing seed funding to viable civic action plans developed by the fellows.

LESSONS

- A valuable lesson from the fellowship is the power of building networks, partnerships, and alliances with other organizations, stakeholders, and individuals. We have learned that collaborative efforts amplify and enhance the impact of the fellowship in advocating for change in our communities through training and mentorship.
- The fellowship recognizes the need for an adaptive approach to address evolving challenges. We have learned the importance of flexibility, agility, and the ability to pivot strategies when faced with unforeseen circumstances, and therefore, adopted an adaptive mindset and continuous learning and innovation to provide quality learning outcomes.
- The need for capacity building emerges as a key lesson from the fellowship. We have learned that equipping the community champions with comprehensive training, mentorship, and resources; and building their capacity in leadership, project management, advocacy, and resource mobilization enhances their effectiveness in implementing their projects and running their organizations effectively.
- The fellowship highlights the significance of engaging in advocacy and policy dialogue to influence systemic change. We have learned the need to strategically navigate policy environments and utilize evidence-based approaches in advocating for sustainable solutions.

NEXT STEPS

Our plans for sustainability

Web Application – we plan to develop a customized instructor-led web (learning) application containing all the modules with advanced features structured with an option of self-paced study.

Partnership – we plan to partner with reputable universities and organizations to review the program curriculum to support modern-day learning and address contemporary civic and governance challenges.

Project Incubation – we plan to increase the number of innovative ideas to incubate in each cohort as we look forward to increasing the number of fellows.

In-person Summit - after the online learning sessions, we plan to converge all fellows of each cohort in a selected location for an in-person Civic Changemakers Day, where they will meet, network, and share perspectives on approaches to improve civic participation in their communities with global experts.

Internship – we plan to connect fellows with our partner organizations to work and get hands-on experience.
